Agenda 1: To read and approve the minutes of 35th IQAC meeting held on 15th October 2024

Agenda 4: To discuss the Third Semester Examination of Batch 2023-25

Examination Convener informed that the Third Semester Examination of Batch 2023-25 had been conducted during 18 November to 26 November 2024. The Strategic Management Examination which was conducted by Mumbai University, was held on 16 December 2024. The MMS third semester result is expected in the end of January or early February 2025.

Agenda 5: Course Outcome (CO) and Direct Program Outcome (PO) Attainment for Semester 3 of Batch 2023-25

It has been informed that the respective faculty members have started working on CO and Direct PO Attainment of their third semester courses of Batch 2023-25.

Agenda 6: To discuss the First Semester Mid Term and End Term Examination of Batch 2024-26

Examination Convener informed that the First Semester midterm examination of Batch 2024-26 had been conducted during 18 November to 4th December 2024. Irrespective of the course credit (half/full credit), the full score of Midterm test was 20. The faculty members of half credit courses need to scale down the midterm score.

The End Term Examination of First Semester of the same batch had been held during 3rd January to 14th January 2025. The question papers of half credit and full credit courses had been designed according to the Mumbai University Circular 2024.

Agenda 7: Committee Meetings

It had been announced by the Director during Internal Faculty Meeting (IFM) on 2nd January 2025, that there will be Committee Meetings (Statutory and Non-Statutory) on first and third Thursdays of the month. He also declared that the second Thursdays would be for Internal Faculty Meetings (IFM) and every fourth Thursdays would be dedicated for Research Review Meet, wherein the faculty members need to present their research papers (published or working paper) and case studies.

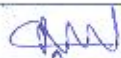

1	Third Semester Examination of Batch 2023-25	The third-semester result was declared on 1 st February 2025. All the students have cleared the exam.
2	Course Outcome (CO) and Direct Program Outcome (PO) Attainment for Semester 3 of Batch 2023-25	Decoded answer sheets had been shared with the concerned faculty members, but IQAC is yet to receive the subject-wise CO Attainment from them.
3	First Semester Mid Term and End Term Examination of Batch 2024-26	First Semester Midterm & End Term examinations had been conducted smoothly and on time. The first-semester result was declared on 4 March 2025
4	Committee Meetings	During the last quarter, a total 12 Committee Meetings (both Statutory and Non- Statutory had 6) were held on the 1 st and 3 rd Thursdays. IQAC received the MoM of most of these committee meetings. Since January 2025, there have been 8 Research Review Presentations made by the Faculty Members.
5	SIP & Capstone	SYMMS Students started working on the Capstone projects under the guidance of the Faculty mentors. The submission timeline had been shared with them. The Plagiarism Software e-Aarjav had been subscribed and the students had been informed that their report would be accepted if and only if the maximum level of similarity did not exceed 20%. Capstone Viva- 8 & 9 April 2025 SIP will be from 2 nd May- 30 June 2025 To date, 46 (out of 126) students have received the SIP offer.
6	Placement	To date, 36% of the students (Batch 2023-25) have received final placement
7	New Committee	The New IQAC Committee has been made with effect from January 2025
