Meet The Celebrity - Mr. Ninad Karpe Author Bond to Baba

What could be common between Marathi blockbuster Sairaat movie, Baahubali, Pro Kabaddi League and corporate strategy? The book "BOND to BABA - Successful Strategies" by Mr. Ninad Karpe, Director, Aptech Limited and former Chairman, Confederation of Indian Industries - Western Region, draws corporate strategy lessons from real life examples across entertainment, sports and politics. Inspired by a range of subjects, the book derives useful lessons for business leaders, managers, students and anyone interested in the practical application of strategy.

Mr. Ninad Karpe, the author, interacted with the students and faculty of Durgadevi Saraf Institute of Management Studies under program Meet The Celebrity.

While introducing the book to the audience Mr. Karpe, said, "The book draws parallels from recent happenings and significant historical events to understand the strategies that could be used in creating brands. It is my endeavour to reveal practical applications of strategy in today's dynamic and ever-changing digital world."

From James Bond to [Baba Ramdev](#), Mr. Karpe gave a compelling account of strategic insights that can be extracted from 10 unconventional profiles – James Bond; Kabaddi; Formula One; Hardik Patel; Alexander the Great; soccer; Baahubali; Alok Kejriwal, [Baba Ramdev](#); and the surprise Marathi blockbuster, Sairat.

Mr. Karpe sprinkled the narrative with his personal experiences and perspectives, adding high credibility to his keen observations. He asserted that leaders need to "constantly rethink, reinvent, and reboot." For instance, using Skyfall he illustrated how the five-decade-old legendary Bond franchise, highlighted the key role of emotional quotient, judgement, and intuition in business. Equally fascinating is how "pincer strategy," a war tactic or a manoeuvre used by Alexander to attack the enemy from both sides, has been applied worldwide by corporates to unsettle competitors.

Towards the closure of the event he interacted with students and faculties admitting that there is no perfect roadmap for evolving and implementing strategies using snippets of relevant examples. He was felicitated by Director Dr. C. Babu

Thought Leadership - The Art of Business Networking - Mr. Manoj Gursahani

Identify the quality of people and stop obsessing about the quantity." He concluded giving a few useful tips like building rapport, nurture a relationship, value people and more importantly look for long term opportunities not quick gains.

DSIMS - RURAL IMMERSION 2017

Every year, students of Durgadevi Saraf Institute of Management Studies (DSIMS) undergo Rural Immersion. Every rural immersion involves a visit to rural areas of a district of our country, for experiential learning about life and economic activities of rural population, which many students living in urban areas are not acquainted with. Through these immersions, DSIMS students get an opportunity to learn about entrepreneurship, self-employment, micro-finance, functioning of supply chains and environmental sustainability practiced in villages of our country and challenges faced by them.

In November 2017, DSIMS students visited rural areas of Anand district of Gujarat. During the immersion, students learnt about world's first co-operative for solar-powered irrigation in Dhundi village, a tobacco co-operative operating successfully since six decades, manufacture of bio-gas and organic fertilizers, manufacture of butter and milk powder by Amul, hand weaving and packaging of spices by members of SEWA (a self-help group) and development of Thamna, a model village. They also learnt about activities of National Dairy Development Board, which has been pivotal in development of co-operatives in various states of India and learnt how students can gain rural-oriented management education at Institute of Rural Management. The immersion concluded with a visit to a botanical park in Vehrakhadi, maintained by Forest Department of Gujarat Government, thereby learning importance of environmental friendliness.

The DSIMS students returned to Mumbai, richer in knowledge and experience about the rural half of India.
