### ACADEMICS

Our 9<sup>th</sup> MMS (2018-20) batch comprising of 115 students graduated with a satisfying pass percentage. Our 8<sup>th</sup> PGDM (18-20) batch comprising of 115 students made us feel proud with 98 pass percentage with good grades. Academic Topper for MMS for 18-20 batch was Ms. Charvi Shukla and in PGDM our academic topper was Col. Sunil Kumar.

Durgadevi Saraf Institute of Management Studies (DSIMS), despite continued lockdown in phases during this period (Mid-March 2020-April 2021) functioned normally using online mode both for academic and administrative activities. Most of the administrative staff attended the office by following Government of India and Maharashtra Government norms. In the month of September 2020 most of the faculty members attended the office in staggering basis. The faculty and staff above 65 years were allowed to work from home. ## Capstone

As per schedule, Capstone project was submitted through soft copies by PGDM and MMS students. Timely evaluation of both faculty evaluation and capstone viva have been completed.

### One-month online certification program on Communication Skills:

From 10<sup>th</sup> June 2020, (DSIMS) started its first one-month online certification program in Communication Skills. With a batch of 20 graduate students with varied educational backgrounds this online program is conducted Zoom platform. Sixteen sessions of one and a half hours each were scheduled with the aim to sharpen the overall communication skills of the students and boosting their self-confidence. All the online classes are being conducted on –Zoom Platform using power-point presentations, Video clips and a lot of interactive discussions held between faculty and students. At the end of the program every participant is being awarded with an online course completion certificate from DSIMS.

### **Coursera Courses**

### FACULTY DEVELOPMENT & MANAGEMENT DEVELOPMENT PROGRAMS

- In-House Faculty Development Program for Faculty Members started from 26<sup>th</sup> June, 2020 and this program was to be conducted on different topics by each faculty for 90 minutes which would continue till 17<sup>th</sup> July 2020.
- On 10<sup>th</sup> July 2020, Faculty Development Program on "Plagiarism" was organised by HEF. The FDP was facilitated by Dr. Kirti Arekar, Associate Professor at K J Somaiya Institute of Management Studies & Research, Mumbai and others. Dr. C. Simulations aim to provide an experience as close to the 'real life situation' as possible; however, a simulated activity has the advantage of allowing learners to 'reset' the scenario and try alternative strategies and approaches. This allows learners to develop experience of specific situations by applying their wider learning and knowledge. The instructors also differentiated between a case study and a simulation where it says that business simulation considers studying industry conditions, understanding customer, strategy formulation, managing operations, conducting study after every period of play and presenting situation analysis for present and future.

Director General of BCCI, Dr. Sandeep Khosla in his opening remarks mentioned that there are currently 3000 active members with the Chamber, of which 2200 members are from the MSME sector. BCCI is in the process of drafting a White paper on MSME's revival strategy, which is to be published in the month of August, 2020.

The theme of the webinar was MSME-WAY FORWARD. It was an interactive session with Dr. Harshadeep Kamble, IAS, Secretary (Small and Medium Industries) and Development Commissioner (Industries) Government of Maharashtra. Dr. Harshadeep Kamble in his address mentioned that in this pandemic year the businesses should try to remain afloat. He also informed that, during his tenure, the MSME state budget has been increased from INR 5 crores to INR 10 crores under the aegis of the New Industrial Policy. He put in his records his appreciation for the Import Substituting MSME Units and promised to offer state support to strengthen those units.

- Mr. Lancy D'Souza, Advocate of Bombay High Court was the other speaker who enlightened the audience about the legal problems faced by the MSMEs.

To control the crisis, uniformly coordinated global policies should be in place. In economies like India, adequate government intervention, particularly for the MSMEs is critically important to revive the economic slowdown

His advice to the Indian money market is to take a proactive look, avoid speculation and maintain a balanced portfolio to yield the best returns as the economy slowly recovers.

Professor Dr. Pradeep Pendse, Dean, WeSchool, was the Speaker and Facilitator. Professor A K Sengupta of HEF India was the Principal Facilitator and he was accompanied by an illustrious and distinguished team from academia as Project Managers.

The major takeaways from Dr. Pendse's session may be summarized as follows:

- ii) We learned the importance of nurturing Design Thinking among students as it leverages creativity and stimulates innovative and Entrepreneurial spirit among them.
- iii) He deliberated on Design Thinking process. A financially viable, desirable, and technically feasible design ultimately lead to a sustainable innovation.

Dr. Sumana Chaudhury attended E-Conference on NEP 2020: Impact on PGDM Education dated 29th August, 2020.

# The E-Conference deliberated on the following aspects of NEP 2020:

- 1. The Impact of the NEP 2020 on management education in general, particularly over 500 PGDM granting B-schools.
- 2. Challenges and opportunities of NEP 2020 for B-schools.
- 3. Planning the future roadmap to align and benefit from this landmark policy.

### • 3<sup>rd</sup> & 4<sup>th</sup> November, 2020

"Dr Nehal Joshipura from DSIMS attended Morningstar Investment Conference on Nov 3-4, 2020. This internationally acclaimed conference is organised every year to discuss issues related to Indian Investment Industry and is attended by most of the market participants. This year also the conference had 15 technical sessions with panel discussions and lectures by industry leaders followed by Q&A.

Speakers included International funds managers like Samir Arora from Helios Capital, Singapore and Rupal Bhansali from Ariel investments, USA. Samir explained how non-diversified portfolio is a mistake and companies going from good to great do not continue to remain great. Rupal spoke of non-consensus investing based on her popular book on it and her practice in international investment.

Veteran investor like Sujoy Bhattacharya spoke about what is actually value investing and how PE ratios are delusional. Sanjay Baxi, adjunct prof. at MDI and fund-manager spoke on behavioural finance. In a panel discussion on Debt market, Prof. Anant from SPJIMR said, "Debt market needs truth and transparency in disclosures for objective valuations." The panel agreed that below AA category, valuation has to be subjective in absence of proper disclosures.

There were interesting sessions delivered by Narayan Murthy, founder-Infosys and Lord Nicolas Stern, Prof at LSE. The conference ended with the closing remarks on emerging investment trends like ESG, Passive investing, role of psychology etc.

## • 13th February, 2021 - Union Budget Webinar

Dr. Sumana Chaudhury attended a Webinar organized by ENQUBE Collaborations on Union Budget 2021-2022- Indian Economy - A Way Forward, on 13<sup>th</sup> February, 2021 at the invitation of Dr. Narendra, Former CMD IOB and Advisor ENQUBE Collaborations.

The Webinar was addressed by six luminary speakers, veteran bankers and economists from Banking sector, Regulatory bodies, and Corporates.

The Chief Guest Mr. Anand Sinha, Former Deputy Governor, RBI in his inaugural speech focused on the Execution aspect of this year's budget. He deliberated on the macro risk issues and suggested some challenging measures to level up the economy on the alphabetical recovery path.

The other Panelists were Dr. Shubhada M Rao (Founder, Quant Eco Research), Mr Ananth Narayan (Senior India Analyst, Observatory Group, LLC and Associate Professor SPJIMR), Mr. R Kannan (Former Head

Corporate Performance, Hinduja Group), Ms. Dipti Deshpande (Senior Economist, CRISIL), and Mr. Sunil Goyal (Co-Founder Ladderup- Kreston SGCO Group).

The Panelists critically analysed the Union Budget 2021-22. They deliberated on the six pillars of Budget 2021, namely, structural reforms under Atmanirbhar Bharat and it's long term Impact on Indian economy, National infrastructure pipeline under PPP mode and its implementation thereof, financial sector reforms, disinvestment target achievability and privatization of strategic and Non-strategic PSUs. The Webinar had a rich discourse on the impact of Union Budget 2021 and immensely benefitted the audience with learning from the insightful analysis of the distinguished panelists and discussants.
